## Why do we need a political action committee (PAC) like GASPAC?

GASPAC funds allow CSA the ability to support candidates and/or elected officials who understand and champion critical anesthesiologist issues, such as:

- Promoting physician-led anesthesia care
- Protecting MICRA
- Defeating inappropriate efforts to expand mid-level provider scope of practice

- ▶ GASPAC funds raise CSA's profile and recognition at the State Capitol and position the organization as a strong patient advocate to the Legislature and regulator arena.
- ▶ There is strength in unity and numbers.
- ▶ Making various contributions to key individuals on behalf of CSA places and keeps our name at the forefront of healthcare related discussions.
- ▶ GASPAC allows CSA to be proactive in the political arena in and around the State Capitol.

## Who can contribute?

- Every member of CSA should contribute to GASPAC
- Corporate entities, such as anesthesia groups, may also contribute
- Maximum contribution per calendar year is \$7,000
